ASUHAN KEBIDANAN KOMPREHENSIF PADA Ny. H UMUR 31 TAHUN DI PMB NURMAINI, S.Tr.Keb DESA SENDANG RT 06 RW 01 KEC BRINGIN KAB SEMARANG

ABSTRAK

Latar Belakang : Pelayanan kebidanan komprehensif dan berkualitas merupakan pelayanan antenatal terpadu yang dilakukan tenaga kesehatan melalui pelayanan kesehatan yang meliputi kehamilan, persalinan, nifas, bayi baru lahir, dan neonatus. AKI tahun 2019 Kematian Ibu dan Angka Kematian Bayi di kabupaten Semarang mengalami peningkatan cukup tinggi. AKI tahun 2019 sebesar 76,93 / 100.000 KH , AKB 8,24 / 1000 KH dan AKAB 24/1000 KH Jumlah kematian maternal yang terjadi pada saat hamil sebanyak 3orang (33,33%), dan pada saat nifas sebanyak 6orang (66,67%).

Tujuan Penelitian : Mampu melakukan asuhan kebidanan pada Ny. H secara komprehensif meliputi masa kehamilan, persalinan, nifas, bayi baru lahir dan neonatus sesuai manajemen Varney 7 langkah dan pendokumentasian dengan metode SOAP.

Metode : Penulis ini menggunakan metode pengumpulan data yaitu melalui wawancara, observasi, pemeriksaan fisik, pemeriksaan penunjang, studi dokumentasi, dan studi pustaka. Pada tanggal 14 juni – 01 juli 2021.

Hasil : Asuhan pada kasus Ny.H setelah dilakukan pengkajian sampai evaluasi dari kehamilan, bersalin, nifas, bayi baru lahir, dan neonatus sejak tanggal 14 Juni 2021 sampai 1 juli 2021. Evaluasi hasil Ny. H selama kehamilan tidak ditemukan kelainan. Asuhan pada persalinan ditemukan kesenjangan yaitu IMD hanya dilakukan dalam 30 menit dan tidak berhasil menyusui sendiri maka dilakukan bantuan atau diajari menetek dan berhasil namun waktunya kurang, hanya dilakukan 30 menit sedangkan dalam teori IMD dilakukan selama 1 jam, sehingga terdapat kesenjangan antara teori dengan kasus. Asuhan masa nifas tidak terdapat kesenjangan. Asuhan pada bayi baru lahir Ny. H berjenis kelamin perempuan, tidak ditemukan adanya cacat serta tanda bahaya.

Kesimpulan : Setelah dilakukan asuhan kebidanan secara komprehensif terdapat kesenjangan antara teori dan fakta yang terjadi pada kehamilan dan persalinan.

ABSTRACT

Background: Comprehensive and quality midwifery services are integrated antenatal services carried out by health workers through health services which include pregnancy, childbirth, postpartum, newborns, and neonates. MMR in 2019 Maternal Mortality and Infant Mortality Rate in kabupaten semarang City experienced a fairly high increase. MMR in 2019 was 76.93 / 100,000 KH, IMR 8.24 / 1000 KH and AKAB 24/1000 KH The number of maternal deaths that occurred during pregnancy was 3 people (33.33%), and at the time of childbirth as many as 6 people (66, 67%). Research Objectives: Able to perform midwifery care on Ny. H comprehensively covers the period of pregnancy, childbirth, postpartum, newborn and neonate according to Varney's 7 steps management and documentation using the SOAP method.

Methods: This author uses data collection methods, namely through interviews, observations, physical examinations, supporting examinations, documentation studies, and literature studies. On June 14 - July 1, 2021.

Results: Care for Mrs. H's case after an assessment to evaluation of pregnancy, childbirth, postpartum, newborns, and neonates from June 14, 2021 to July 1, 2021. Evaluation of the results of Ny. H during pregnancy there were no abnormalities. There were found gaps in delivery care, namely IMD was only carried out in 30 minutes and did not succeed in breastfeeding alone, then assistance was carried out or taught to suckle and it was successful but the time was less, it was only done 30 minutes while in theory IMD was carried out for 1 hour, so There is a gap between theory and case. There is no gap in postpartum care. Care for the newborn Mrs. H is female, no defects or danger signs were found.

Conclusion: After comprehensive midwifery care has been carried out, there is a gap between theory and facts that occur in pregnancy and childbirth.
