**GAMBARAN PERENCANAAN PENGADAAN SEDIAAN FARMASI DI INTALASI  
FARMASI KLINIK “X” KABUPATEN SEMARANG**

**ABSTRAK**

**Latar Belakang:** Pengelolaan sediaan farmasi di Instalasi Farmasi Klinik perlu dilakukan dengan baik untuk menjamin kelangsungan ketersediaan dan keterjangkauan pelayanan obat yang efisien, efektif dan rasional. Tujuan dilakukan penelitian ini untuk mengetahui gambaran dan kesesuaian pada tahap perencanaan pengadaan sediaan farmasi di Instalasi Farmasi Klinik “X” Kabupaten Semarang.

**Metode:** Metode penelitian yang digunakan data dianalisis berdasarkan rancangan penelitian deksriptif evaluatif yang bersifat *prospektif*. Bahan penelitian meliputi data yang diperoleh dari wawancara mendalam (*indepth interview*) kepada informan.

**Hasil:** Hasil penelitian yang diperoleh mengenai gambaran perencanaan di Instalasi Farmasi Klinik menggunakan metode konsumsi dengan melihat konsumsi obat periode sebelumnya. Hal ini sesuai dengan yang tertera di Buku Pedoman Pelayanan Kefarmasian di Apotek tahun 2020. Gambaran pengadaan di Instalasi Farmasi Klinik menggunakan metode pembelian langsung yaitu berdasarkan pada kebutuhan. Pada tahap pengadaan ini terdapat kekurangan dari sistem pengadaan dikarenakan ketidaksesuaian pengadaan dengan perencanaan padahal menurut Seto, *et al* (2012), syarat penting dalam fungsi pengadaan obat harus sesuai perencanaan, sesuai kebutuhan, dan sesuai ketentuan sistem atau cara pengadaan.

**Kesimpulan:** Berdasarkan penelitian yang dilakukan dapat ditarik kesimpulan bahwa perencanaan dan pengadaan sediaan farmasi di Instalasi Farmasi Klink kurang sesuai dengan literatur yang ada, karena antara pengadaan dengan perencanaan tidak selaras

**DESCRIPTION OF PLANNING PROCUREMENT OF PHARMACEUTICAL  
SUPPLIES IN INSTALLATION OF PHARMACEUTICAL CLINIC "X" SEMARANG

**ABSTRACT**

**Background:** The management of pharmaceutical preparations at the Clinical Pharmacy Installation needs to be carried out properly to ensure the continuity of the availability and affordability of efficient, effective and rational drug services. The purpose of this study is to determine the description and suitability of the planning stage of the procurement of pharmaceutical preparations at the "X" Clinical Pharmacy Installation, Semarang Regency

**Methods:** The research method used was data analyzed based on a prospective evaluative descriptive research design. Research materials include data obtained from in-depth interviews with informants.

**Result:** The results obtained regarding the planning description at the Clinical Pharmacy Installation using the consumption method by looking at the drug consumption of the previous period. This is in accordance with what is stated in the Guidebook for Pharmaceutical Services at Pharmacies in 2020. The description of procurement at the Clinical Pharmacy Installation uses the direct purchase method, which is based on need. At this stage of procurement, there are deficiencies in the procurement system due to the incompatibility of procurement with planning whereas according to Seto, et al (2012), an important requirement in the function of drug procurement must be according to planning, according to needs, and according to the provisions of the system or procurement method.

**Conclusion:** Based on the research conducted, it can be concluded that the planning and procurement of pharmaceutical preparations at the Klinik Pharmacy Installation is not in accordance with the existing literature, because the procurement and planning are not aligned.
