ABSTRAK

Penerapan sanksi dapat menciptakan efek jera pada para pelaku tindak penganiayaan. Kasus kekerasan, pengeroyokan yang mengakibatkan penganiayaan adalah termasuk kedalam bentuk pelanggaran hukum yang sudah di atur dalam UU Pasal 351-358 KUHP. Penelitian ini adalah jenis penelitian Hukum, penelitian menggunakan metode Yuridis Normatif. Adapun latar dari penelitian ini adalah Pengadilan Negeri Purwodadi sebagai objek penelitian dan Hakim Pengadilan Negeri Aldhytia Kuriniawan Sudewa, .SH, .MH sebagai informan. Wawancara mendalam digunakan oleh peneliti dalam menjawab suatu dugaan kebenaran yang masih sementara dengan teknik analisis deskriptif. Hasil penelitian ini diketahui bahwa dalam menanggulangi tindak penganiayaan di berikan penerapan sanksi yang telah di atur dalam KUHP Pasal 353-358 Selain itu masyarakat juga harus ikut berpartisipasi dalam hal pelaporan apabila terdapat kasus kekerasan, pengeroyokan dan penganiayaan yang dilakukan oleh remaja.

Application of criminal sanctions against criminal acts of abuse committed by juveniles based on Law Article 351-358 of the criminal Code

ABSTRACT

The application of sanctions can create a deterrent effect on perpetrators of acts of persecution. Cases of violence, beatings that result in persecution are included in the form of legal violations that have been regulated in Article 351-358 of the Criminal Code. This research is a type of legal research, research using the normative juridical method. The background of this research is the Purwodadi District Court as the object of research and District Court Judge Aldhytia Kuriniawan Sudewa,.SH,.MH as informants. In-depth interviews are used by researchers in answering an allegation of truth that is still tentative with descriptive analysis technique. The results of this study note that in tackling acts of abuse, sanctions have been applied that have been regulated in the Criminal Code Articles 353-358. In addition, the community must also participate in reporting if there are cases of violence, beatings and abuse committed by teenagers.
