PERSEPSI IBU HAMIL TERHADAP KELAS IBU HAMIL DI MASA PANDEMI COVID-19 DI PUSKESMAS JETIS II DESA PATALAN, KECAMATAN JETIS, KABUPATEN BANTUL, YOGYAKARTA

ABSTRAK

Latar Belakang : Kelas Ibu Hamil bermanfaat untuk meningkatkan pengetahuan dan keterampilan ibu hamil mengenai kehamilan, perawatan kehamilan, persalinan, perawatan nifas, perawatan bayi baru lahir, mitos, penyakit menular dan akte kelahiran. Namun pada masa Pandemi Covid-19 pelaksanaan kelas ibu hamil mengalami penurunan. Salah satu penyebab penurunan pelaksanaan kelas ibu hamil adalah karena persepsi ibu hamil. Pelaksanaan kelas ibu hamil di Puskesmas Jetis II, Bantul Yogyakarta dilakukan secara offline dengan penerapan protocol kesehatan yang ketat.

Tujuan penelitian : Untuk mengetahui persepsi ibu hamil terhadap kelas ibu hamil di Puskesmas Jetis II, Desa Patalan, Kecamatan Jetis, Kabupaten Bantul, Yogyakarta.

Metode : Jenis penelitian Deskriptif kuantitatif dengan pendekatan Cross Sectional. Jumlah populasi sebanyak 60 ibu hamil. Teknik pengambilan sampel menggunakan metode *total populasi* dengan instrument penelitian kuesioner. Analisis data menggunakan distribusi frekuensi

Hasil : Hasil penelitian persepsi ibu hamil terhadap kelas ibu hamil kategori *perceived susceptibilty* sebagian besar yaitu persepsi positif sebanyak 44 responden (73.3%), kategori *perceived severity* sebagian besar persepsi positif sebanyak 45 responden (75%), kategori *perceived benefit* sebagian besar persepsi positif sebanyak 44 responden (73.3%), *perceived barrier* sebagian besar persepsi positif sebanyak 35 responden (58.3%), kategori *cues to action* sebagian besar persepsi positif sebanyak 39 responden (65%) dan persepsi ibu hamil terhadap kelas ibu hamil sebesar secara umum sebagian besar persepsi positif sebanyak 34 responden (56.7%).

Simpulan : Persepsi ibu hamil terhadap kelas ibu hamil di masa pandemic covid-19 di Puskesmas Jetis II yaitu sebagian besar persepsi positif sebanyak 34 responden (56.7%).

ABSTRACT

Background: The Class of Pregnant Women is a means to learn together about health for pregnant women, in the form of face-to-face in groups that aims to improve the knowledge and skills of mothers regarding pregnancy, pregnancy care, childbirth, postpartum care, newborn care, myths, infectious diseases and birth certificates . The perception of pregnant women towards the class of pregnant women in Puskesmas Jetis II, Bantul Yogyakarta is good, this is evidenced by the active class program of pregnant women.

Purpose : To find out the perception of pregnant women to the class of pregnant women in Puskesmas Jetis II, Patalan Village, Jetis Subdistrict, Bantul Regency, Yogyakarta.

Method: Type of quantitative descriptive research with a Cross Sectional approach. Population of 60 pregnantwomen. Sampling technique using *total populasi* method with questionnaire research instrument. Data analysis using Univariate Analysis.

Results: The results of the study of the perception of pregnant women to the class of pregnant women *perceived susceptibilty* category mostly positive perception as much as 44 respondents (73.3%), *perceived severity* category mostly positive perception as many as 45 respondents (75%), *perceived benefit* category mostly positive perception as many as 44 respondents (73.3%), *perceived barrier* Most of the positive perceptions as many as 35 respondents (53.3%), *the category of cues to action* mostly positive perceptions as many as 39 respondents (65%) and the perception of pregnant women to the class of pregnant women as much as the majority of positive perceptions as many as 34 respondents (56.7%).

Conclusion: The perception of : pregnant women towards the class of pregnant women during the covid-19 pandemic in Puskesmas Jetis II is mostly positive perception as many as 34 respondents (56.7%).
