**HUBUNGAN FUNGSI MANAJEMEN KETUA TIM TERHADAP PELAKSANAAN
SISTEM SKOR PERINGATAN DINI PADA PELAYANAN KEPERAWATAN DI RSUD
DR. GONDO SUWARNO**

ABSTRAK

Latar belakang: Pelayanan asuhan keperawatan yang bermutu membutuhkan peran aktif dari ketua tim. Ketua tim sebagai pelaksana fungsi manajemen perencanaan, pengorganisasian, pengarahan dan pengawasan, berperan sebagai fasilitator komunikasi dan kolaborasi antara perawat serta memberikan umpan balik asuhan keperawatan salah satunya pelaksanaan sistem skor peringatan dini agar dapat dilakukan secara terfokus dalam mengobservasi, menilai, mendeteksi dan merespon dengan cepat.

Tujuan: mengetahui hubungan fungsi manajemen ketua tim dengan sistem skor peringatan dini.

Metode: menggunakan desain penelitian kuantitatif korelasional dengan pendekatan *cros sectional*, populasi target adalah perawat di RSUD dr. Gondo Suwarno, jumlah sampel 60 perawat pelaksana menggunakan teknik *total sampling*. Pengambilan data menggunakan kuesioner fungsi manajemen ketua tim dan pelaksanaan sistem skor peringatan dini, telah dilakukan uji validitas dan reliabilitas ulang. Analisa bivariat menggunakan *Chi Square*.

Hasil: Fungsi manajemen ketua tim sebagian besar dalam kategori baik sebanyak 45 (75%) kurang sebanyak 15 (25%), pelaksanaan sistem skor peringatan dini sebagian besar dalam kategori baik sebanyak 49 (81,7%) kurang sebanyak 11 (18,3%), Ada hubungan dengan korelasi antara fungsi manajemen Ketua Tim dengan pelaksanaan sistem skor peringatan dini dengan *p value* <0,001 sehingga nilai *p* < 0,05.

Saran: Diharapkan ketua tim perawat dapat meningkatkan fungsi manajemen secara komprehensif dalam pelaksanaan sistem skor peringatan dini.

**THE RELATIONSHIP BETWEEN TEAM LEADER MANAGEMENT FUNCTIONS
AND THE IMPLEMENTATION OF EARLY WARNING SCORE SYSTEM IN
NURSING SERVICES AT RSUD DR. GONDO SUWARNO**

ABSTRACT

Background: High-quality nursing care requires an active role from the team leader. The team leader serves as the implementer of management functions such as planning, organizing, directing, and supervising. Additionally, they act as a facilitator of communication and collaboration among nurses, providing feedback on nursing care, including the implementation of early warning score systems to enable focused observation, assessment, detection, and rapid response.

Objective: knowing the relationship between the Team Leader's management functions and the Early Warning Score System (NEWS) is essential.

Method: Using a quantitative correlational research design with a cross-sectional approach, the target population is the nurses at RSUD dr. Gondo Suwarno, with a sample size of 60 practicing nurses selected through total sampling technique. Data collection involves administering questionnaires on the team leader's management functions and the implementation of the early warning score system. Validity and reliability tests have been conducted on the instruments. Bivariate analysis will be performed using the Chi-Square test.

Result: Team Leader management functions were mostly in the good category, accounting for 45 (75%), while the implementation of NEWS was also mostly in the good category, with 49 (81.7%). There is a correlation between Team Leader management functions and the implementation of NEWS with a p-value <0.001, indicating that the p-value is < 0.05.

Suggestion: The expectation is that the nurse team leader can enhance comprehensive management functions in the implementation of the early warning score system.
