**Upaya Kepolisian Lalu Lintas Dalam Penanggulangan Pelanggaran

ABSTRAK

Latar belakang: Masih tingginya tingkat kecelakaan lalu lintas kendaraan sepeda motor yang dikemudikan oleh anak di wilayah hukum Polres Magelang Kota, dengan berbagai permasalahan yang ada di lapangan, maka peneliti tertarik untuk meneliti lebih mendalam. Penelitian ini dilakukan karena meskipun pihak kepolisian lalu lintas sudah melakukan berbagai upaya untuk meminimalisir angka kecelakaan yang melibatkan anak-anak, namun ternyata masih banyak yang melanggar.

Tujuan: mengetahui upaya dan model penegakan hukum kepolisian lalu lintas dalam menanggulangi pelanggaran lalu lintas yang dilakukan oleh anak sebagai pengendara sepeda motor di wilayah hukum Polres Magelang Kota.

Metode: Desain penelitian kualitatif dengan pendekatan yuridis empiris.

Hasil: Upaya dan model penegakkan hukum yang dilakukan oleh kepolisian lalu lintas Polres Magelang Kota dalam menanggulangi pelanggaran lalu lintas pengendara motor oleh anak, yaitu melakukan tindakan preventif dengan cara memberikan edukasi, pendampingan, dan sosialisasi kepada orang tua anak, serta melakukan penyuluhan melalui program police goes to school. Tindakan represif juga dilakukan berupa teguran kepada si anak dan orang tua, dan penindakan tilang.

Saran: Disarankan bagi polisi lalu lintas agar juga memberikan hukuman sosial bagi si anak, seperti push up, mengunggah foto kejadian di media sosialnya sendiri, dan lainnya.

***Traffic Police Efforts in Handling Motorcyclist Violations by Children in the
Jurisdiction of the Magelang City Police***

ABSTRACT

Background: *The still high rate of motorcycle traffic accidents driven by children in the jurisdiction of the Magelang City Police, with various problems in the field, the researcher is interested in conducting further research. This research was conducted because although the traffic police have made various efforts to minimize the number of accidents involving children, it turns out that there are still many who violate.*

Objective: *to determine the efforts and law enforcement models of traffic police in overcoming traffic violations committed by children as motorcyclists in the jurisdiction of the Magelang City Police.*

Method: *Qualitative research design with an empirical legal approach.*

Results: *Efforts and law enforcement models carried out by the Magelang City Police in overcoming traffic violations by motorcyclists by children, namely taking preventive measures by providing education, assistance, and socialization to the child's parents, as well as providing counseling through the police goes to school program. Repressive actions are also carried out in the form of warnings to the child and parents, and issuing tickets.*

Suggestion: *It is recommended for the traffic police to also provide social punishment for the child, such as push-ups, uploading photos of the incident on their own social media, and others.*
