According to Britannica Stephenie Meyer (born December 24, 1973, Hartford, Connecticut, U.S.) is an American author known for the popular *Twilight Saga*, a series of vampire themed novels for teenagers. Meyer, who was raised in Phoenix, Arizona, received a National Merit Scholarship and attended Brigham Young University, where she graduated with a bachelor's degree (1997) in English literature. She married in 1994 and worked as a homemaker, caring for her three sons.

Inspired by a dream, Meyer completed the manuscript for her first book, *Twilight* (2005), in three months. Soon thereafter *Little, Brown and Co* offered her \$750,000 the most the company had ever offered a first time author for the manuscript and two future books. *The Twilight Saga*,

as her series of four books came to be known, tells the story fraught with danger, suspense, and searing passion of teenager Bella Swan and her vampire boyfriend, Edward Cullen. Meyer described her vampires as "very light" sensitive, thoughtful, even beautiful figures rather than blood guzzling predators. Some, like Edward and his family, do not drink human blood. They also do not turn into bats or sleep in coffins, and they travel abroad in daylight. This unconventional take on vampires, along with vivid characterizations and spot-on portrayals of obsessive love and other varieties of teen angst, won Meyer a fervid following among teenage girls.

Twilight won accolades from The New York Times, the American Library Association, and Publishers Weekly, which named Meyer one of the most promising new authors of 2005. The novel introduces Bella as she moves to Washington state and first meets Edward, who instantly falls for her even though he is a vampire. Meyer's second novel, *New Moon* (2006), in which Bella be friends a young werewolf named Jacob Black, topped the list of best-selling children's chapter books in The New York Times within a month of its publication. In the third book, *Eclipse* (2007), Bella must choose between Edward and Jacob, hoping all the while that she does not inflame an age old conflict between vampires and werewolves. After only one day on bookstore shelves, *Eclipse* had sold 150,000 copies. In 2007 the *Twilight Saga* finally edged J.K. Rowling's *Harry Potter* from his perennial perch atop The New York Times best-seller list for series books.

Meyer took a break from her expanding narrative to publish *The Host* (2008). With a similar focus on romantic entanglements between young adults and paranormal beings, the novel presented a world in which extraterrestrials have implanted their consciousness within human bodies, and it extended Meyer's commercial success. She then released what was thought to be the final novel in the *Twilight Saga*, *Breaking Dawn* (2008). Its publication was commemorated by bookstores across the United States with vampire themed parties held before the title went on

sale at midnight. In 2010 Meyer published *The Short Second Life of Bree Tanner*, a novella about a "newborn" vampire that appeared in *Eclipse*. Meyer made a foray into the spy genre with *The Chemist* (2016), which centres on a female former agent who specializes in interrogations. In 2020 she returned to the *Twilight Saga* with *Midnight Sun*, which tells the events from the first book from Edward's perspective.

Breaking Dawn begins the story with preparations for the wedding between Bella and Edward.Bella's bestfriend named Jacob was the one who not attend the wedding because Jacob is still love her. Jacob disappeared until the wedding day, but at the wedding he appears to congratulate Bella.But Jacob was angry with Bella because realizing that Bella would be having her "first night" with Edward while she is still human. Jacob was forced to be removed from the wedding by Sam's gang Uley. Then came the honeymoon period. Edward took Bella to Brazil, after that Edward realized that Bella was pregnant. The fetus in Bella's womb grows abnormally faster.Because Edward is vampire, Edward immediately predicted that the fetus was sucking Bella's blood from within her womb. Edward insisted on aborting the fetus, but Bella was already love the baby. The baby was born after breaking several of Bella's ribs, then Edward force to emerge from the womb by tearing defend Bella's stomach with Edward's hands and teeths. When Bella was dying, Edward injected "poison" from his fangs to Bella's heart with the aim of accelerating Bella's transformation into vampire. Bella fainted for sometime, but Jacob thought Bella was dead. Jacob rushed into the room where Rosalie was holding the baby (Renesmee), with the intention of destroying the baby.
